DOG PURCHASE CONTRACT

THIS AGREEMENT is made by and between

(hereinafter called "Buyer") and VON WA-BO German Shepherds (hereinafter called "Seller")

The purpose of this Agreement is to state the terms and conditions under which Buyer is purchasing a dog from the seller. Seller sells to Buyer, and Buyer purchases from Seller, the following dog (hereinafter called "the dog")

TERM OF SALE:

- 1) Seller shall provide Buyer with the following, upon Buyer's payment in full:
 - a) If the dog is an adult dog: the original pedigree of registry. (Training and show records, if applicable.)
 - b) If the dog is a puppy: AKC registration application shall be given to buyer as soon as they are received from AKC. (Training and show records, if applicable.)
- 2) Buyer further agrees that buyer is solely responsible for any and all actions of the dog and agrees to hold Sellers harmless from any and all claims for bodily injury and/or property damages caused or alleged to have been caused by the dog.
- 3) If buyer can no longer keep the dog, it will be returned to seller at no cost to the seller or buyer may resale the dog and all guarantees provided from the seller will be void. (please notify seller if resale)
- 4) Buyer agrees to pay for all shipping and transportation fee related to the purchase or return of dog.

REGISTRATION: Seller/Breeder has made application to The American Kennel Club for litter registration, and individual dog registration applications will be issued to the buyer as soon as they are received from AKC. The AKC Registration should include the kennel name VON WA-BO and prefix name of the puppy.

HEALTH GUARANTEE: Seller certifies that this dog is, to the best of his/her knowledge, healthy at the time of sale. Vaccination, deworm records and a health background will be provided by the seller if applicable.

- 1) Buyer can return the dog within 3 days of purchased if determined to have any congenital defect. A written report documenting the congenital defect from a licensed veterinarian. Seller shall give Buyer either a full refund of the purchase price or replacement of the dog with one of equal value, at Buyer's option.
- 2) If dog dies within 24 hours of purchase, buyer must have an autopsy performed by a licensed veterinarian at buyer expense to determine cause of death. If cause of death is due to problems existed before time of purchase and after our veterinarian has examined the dog, Buyer has option of : Accepting 100% refund (all paperwork related to the dog must be returned to the seller)
- 3) Seller guarantees that every effort has been made to select breeding stock that has been certified to have sound hips. Seller warrants the puppy/dog against a severe crippling hip dysplasia due to genetic cause until the dog attains the age of One year. Prior to the expiration of this guarantee, if buyer provides seller a written certification by a licensed veterinarian, German "A" stamp program or the Orthopedic Foundation of America (OFA) that the dog has a severe crippling grade of hip dysplasia due to genetically, and if all X-rays of the dog are made available to seller upon request, buyer has option of a replacement German Shepherd Dog or puppy of equal value (when such a dog or puppy becomes available). This certification can be done no earlier than 1 year of age. All veterinary bills and other expenses incurred by Buyer after Buyer takes possession and before buyer returns the dog to seller are the sole responsibility of buyer. Buyer shall be solely responsible for the dog's good health, safety, appearance and temperament after buyer takes possession of the dog and before buyer returns the dog to seller under the terms of this paragraph.

ADDITIONAL TERMS:

ALL WARRANTIES OF SELLER UNDER THIS CONTRACT SHALL BE NULL, VOID AND OF NO EFFECT IF THE DOG HAS BEEN THE VICTIM OF ABUSE, NEGLIGENCE, ACCIDENT OF ANY TYPE, OR IMPROPER DIET THAT RESULTS IN THE DOG BEING UNDERWEIGHT OR LACKING IN PROPER NUTRITION OR IF MALE/FEMALE IS BRED BEFORE THE AGE OF 20 MONTHS. IF THE DOG HAS BEEN OVEREXERCISED BEFORE THE AGE OF 12 MONTHS. Buyer understands that if the dog is a puppy, the condition of hip dysplasia, is often the result of the quality of care and feeding the puppy receives after sale, as well as genetic factors passed on from the parents. Notwithstanding the foregoing, Seller guarantees that every effort has been made to select breeding stock that has been certified to have sound hips.

If any action at law or inequity is necessary to enforce or interpret the terms of this Agreement, the prevailing party shall be entitled to reasonable attorney's fees, costs and necessary disbursements in addition to any other relief to which such party not be entitled. The laws of the State of California shall govern the Agreement. In the event of any suit or action arising from this Agreement, venue shall be in the Orange County, California.
